4. First aid Measures

Description of necessary first aid measures

Immediately hold eyelids apart and flush the eye continuously with running water. **Eye Contact:**

Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by

occasionally lifting the upper and lower lids.

Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes

Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

Skin Contact: Immediately remove all contaminated clothing, including footwear.

Flush skin and hair with running water. (and soap if available).

Lay patient down. Keep warm and rested.

Prostheses such as false teeth, which may block airway, should be removed, where possible, prior to initiating first aid procedures.

Apply artificial respiration if not breathing, preferably with a demand valve resuscitator, bag valve mask device or pocket mask as trained. Perform CPR if necessary.

Transport to hospital or doctor.

Urgent hospital treatment is likely to be needed.

If swallowed do NOT induce vomiting.

If vomiting occurs, lean patient forward or place on left side (head down position if possible) to maintain open

airway and prevent aspiration. Observe the patient carefully.

unconscious.

Give water to rinse mouth, then provide liquid slowly and as much as casualty can comfortably drink
