4. First aid Measures

In case of eye contact: If in eyes, hold eyes open, flood with water for at least 15 minutes. If irritation persists transport to

nearest medical facility for additional treatment.

In case of skin contact: If skin contact occurs, remove contaminated clothing and wash skin thoroughly with water and follow

by washing with soap if available

If Ingested: If swallowed, do NOT induce vomiting. Transport to nearest medical facility for additional treatment. If

vomiting occurs spontaneously, keep head below hips to prevent aspiration.

If Inhaled: Keep victim calm and remove to fresh air if safe to do so. If rapid recovery does not occur, transport

6. Accidental Release Measures

Personal Precautions:

Avoid contact with spilled or released material. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove - 3 - Date: 01/05/2024

all sources of ignition in the surrounding area. Take precautionary measure against static discharge. Ensure electrical continuity by bonding and earthing all equipment.

Environmental Precautions: Use appropriate containment to avoid environmental contamination. Prevent from spreading

and entering waterway using sand, earth or other appropriate barriers. Attempt to disperse the vapour or to direct its flow to a safe location for example by using fog sprays. Ventilate

contaminated area thoroughly.
